**SUBJECT: REGULATORY COMPLIANCE OF COSMETIC PRODUCTS**

The undersigned Fabrizio LAVEZZATO, Chemist Responsible for Research & Development and Quality Control Laboratory of the Company SUTTER INDUSTRIES S.p.A. declares that:

- Cosmetic products listed in Annex A are compliant with legislative requirements laid down into European Regulation 1223/2009/EC;
- Following the legislative provisions laid down into Article n. 4 and subsequent of such Regulation, SUTTER INDUSTRIES S.p.A. holds at its headquarter, the full dossier (P.I.F. – Product Information File), including among other information the ingredients' safety data sheets and the safety evaluation of each product. For products sold in full service the P.I.F. is hold at the headquarter of the Producer. Such documents certify the safety of each formulation, when used in conformity with use destination outlined on the label and reasonably foreseeable uses;
- It is a legislative duty of SUTTER INDUSTRIES S.p.A. the P.I.F. data sharing, free of charge and without any undue delay, with any Competent Authority requiring any clarification for regulatory conformity and safety reason;
- Regulation 1223/2009/EC does not require for cosmetic products the generation of a Safety Data Sheet in compliance with criteria outlined into Regulation 1907/2006/EC and subsequent implementations, Regulation 1272/2008/EC and subsequent implementation and Regulation 830/2015/EC and subsequent implementation;
- With regards to transport regulation (ADR/RID, IMDG, IATA), it is confirmed that cosmetic products listed in Annex A are not classified as dangerous for transport regulation, hence the UN code is not applicable.
